I currently have one employee full time and several young students coming in to learn the trade. I am a certified FAA aircraft mechanic. I am also the secretary of the Cumberland airport committee (formerly airport commission).

Other expenses that are immediate besides the hangar purchase, insulation and addition will also be the relocation of a transformer box to give room for the addition. This has been quoted by Barron Electric at \$2695.00. I am hoping to hire a couple more young people if I can get this business up and running at the airport in Cumberland.

I would use the grant to improve the hangar. The hangar needs to be insulated and heated before the winter. Currently there is no insulation in the hangar. Also the transformer just behind the hangar will need to be moved to allow for the addition. I would also need to add to the hangar. The hangar can only accommodate 2 aircrafts at a time. I would eventually need more space to accommodate more aircraft and therefore more jobs for our community.
