Hello! I know we are not technically a business but we are looking for financial assistance to start a K9 program which was just approved by City Council. With the increase in drug use and criminal activity all over the nation, we feel that this program would greatly benefit the citizens of Cumberland. Currently, there is only one K9 in the entire county working night shift. Soon, there will be none. A K9 can help detect the odor of narcotics so officers can seize narcotics, locate missing and endangered subjects (we just had a missing 11 year old a few weeks ago), provide officer safety as well as safety for the public in emergency situations, apprehend dangerous criminals, etc. In order to start this program, we have to raise approximately \$90,000. If we don't raise the start up costs ourselves, we cannot start the program. We have already raised approximately \$46,000 because of grants and generous donations. We are counting on our supportive and generous community to assist us with raising the rest of the money so we can start the program and hopefully make our community an even safer place to live! The funds would be used to purchase a canine and send an officer to 12 week training.
