- *Salud has created nine employment opportunities as we have over 2,000 clients locally to as far away as Green Bay,. Eau Claire, Hudson, and La Crosse Wisconsin. We have been featured in Voyage Minnesota Magazine as "Wisconsin's Hidden Gem:"
- *We carry local vendor retail items at Salud to collaborate with other local businesses by providing coupons or suggesting places to dine. We only provide local foods as complimentary snacks while in our establishment.

- ** Paint the facade of both sides of the building damaged from graffiti. We have had this done in August.
- *We have already invested on top of purchasing the building \$105,000 on remodeling the historic building.
- -Replacing an air conditioner unit and HVAC air exchange.
- -Refacing the whole front side of our building cost was \$15,000
- -Purchasing pharmaceutical salt therapy supplies cost was near \$40,000
- -Installing organic spray tanning and skin treatments cost was \$32,000
- -Hydro Massage therapy treatment cost was \$18,000
- * Currently looking at having to repair our 6,000 sq ft roof estimate and inspection report provided by Northwest Construction at 40,000.00 being a single person owned business this repair is critical.
